s we head into summer, it's likely that like me, you have planned a vacation. Whether you're going out of town, out of state, or out of the country, there is a lot that goes into vacation planning, and Estate Planning probably doesn't rank on your vacation To Do list. Many travelers purchase travel insurance to protect their vacation investment in case of unpredictable circumstances. Just like travel insurance, Estate Planning can be seen as the "insurance" for the "what ifs" in life.

Here is a list of To-Do's for Your Estate Plan before going on vacation:

#### First Things First - Get an Estate Plan in Place!

If you have not done an Estate Plan at all, now is a good time for you to get something in place, whether it be a Living Trust or a Will-based plan. Through the estate planning process, you determine who will be in charge if something happens to you (either illness, disability or death) and will also define how your estate will be executed in the event of your death or incapacity.

#### **Review Your Existing Estate Plan**

If you already have an estate plan, it may be wise to get your plan reviewed by an attorney and make sure that it is up-to-date. During a review process, the attorney can determine if there's been any changes in laws or planning strategies that you may want to take advantage of. This also gives you the opportunity to review whom you've chosen to be in charge of your financial affairs and medical decisions. Relationships change and reviewing your plan & executors/trustees protects both yourself and any persons directly involved with your estate.

#### Pack Your Health Document Emergency Card

A Health Document Emergency Card is a card provided to our clients at the time of their plan signing. This Health Document Emergency Card is an important card to have in your wallet or passport, especially when you are traveling. If something were to happen to you and you were in need of medical attention, this card would provide doctors and medical staff right away with the necessary legal information and directions they would need to care for you according to your wishes.

#### **HIPAA** Authorization

Likely included in your estate plan is a HIPAA Authorization, which gives a named individual access to your medical records and permission for discussions with medical professionals about your care. You may not be travelling with the individual you've previously named to have access to your medical information, so there may be a benefit to having an additional HIPAA Authorization put in place that would allow your traveling companion(s) to be able to receive and have access to medical information should anything happen to you on your trip.

#### **Guardian Designation**

If you have minor children, you'll likely want to make sure you have a plan in place for them in the unlikely event should you pass away or become injured; it's important to have guardians appointed for any minor children that consider both financial and physical care. Also, if you happen to be the primary caretaker of a disabled family member who is unable to care for him or herself, make sure that person has a backup guardian designation by his/ her legal representation to ensure they are properly cared for should something happen to you.

## **Recipe:** Really Good Pasta Salad from www.inspiredbycharm.com



This macaroni salad is a crowd-pleaser, perfect for those Summer BBQs and celebrations!

## INGREDIENTS Dressing:

#### • 2/3 cup mayonnaise

• 1/2 cup sour cream

- 2 teaspoons Dijon mustard
- 4 teaspoons sweet pickle juice
- 1 tablespoon sugar
- 1 teaspoon salt
- 1 teaspoon pepper

#### Ingredients:

- 6 cups elbow macaroni -1 lb box, cooked
- 1/2 large white onion finely chopped
- 4 celery stalks finely chopped
- 5-6 sweet pickles finely chopped
- 4 hard-boiled eggs chopped
- 1 cup green olives pimentostuffed, sliced in half
- 1 tablespoon fresh dill chopped
- Additional fresh dill for garnish

#### Instructions

1. Begin by cooking the macaroni according to the package

directions. Cook al dente. Drain and rinse under cold running water. Set aside.

- For the dressing, in a mediumsize bowl, whisk together the mayonnaise, sour cream, mustard, pickle juice, sugar, salt, and pepper. Whisk until combined.
- In a large bowl, add the macaroni, onion, celery, pickles, green olives, and dressing. Stir well to coat. Then add the hard-boiled eggs and dill. Stir again to coat. Add extra salt or pepper to taste. Chill in the refrigerator or transfer to a serving bowl. Garnish with fresh dill before serving.
